For preliminary performance nights, choose one of these three nights: Tuesday night - November 27th, Thursday night -November 29th or Friday night -November 30th.

Finalists will be announced at the end of the preliminary performances on Friday, November 30th.

Final performances this year will be Saturday night - December 1st

All preliminary performances begin at 6:30 pm and the final performances begin at 7:00 pm at the Convention Center.

Contestants are asked to be at the Convention Center no later than 6:15 pm.

This year we will award at least \$10,000 in Prize Money to the finalists. We will also have 2 drawings for \$500 each to be given to two of our choir directors. The Contest will be professionally judged and performances will be recorded for playback on V-105.5 FM

Entry Deadline is 5:00 PM Friday, November 16th. If you are using a recorded accompaniment track with your performance, we must also have it by 5:00 PM on Friday, November 16th. Tracks on CD can be dropped off at any River Hills Bank location, Mailed to our PO Box.

An acoustic piano will be available for use but any other musical instrument must be furnished by performer. If you have entered and we have not contacted you by Monday, November 19th, call Mark Jones at 601-883-0848 or email mark@vicksburgv105.com to confirm that we have your Entry Form.

Soloists limited to a performance time of 4 minutes maximum and Groups, Bands, and Choirs limited to 5 minutes maximum in their preliminary performances. On finals night, finalist should perform only one song.

In order to keep the caroling contest musically diverse, please do not perform either 'O Holy Night' or 'Mary, Did You Know'. In order to achieve fairness to all schools, for junior high, high school or college choirs, please enter no more than 2 choirs. Bring your best 2 choirs.

Early entry will guarantee your selection of night and placement.
